Biography

Dr. Sebastiano Andreana is a clinical professor and director of The Center for Implant Dentistry at New York University. Previously, a professor, and executive director of the Buhite-Di Mino Implant Center at the University at Buffalo. He graduated from the University of Roma La Sapienza in Dentistry and dental prosthesis and received a Master of Sciences at the University at Buffalo.

Past manager of the Applied Testing Center of Ivoclar Vivadent, Inc., senior manager in Research and Development (R&D), microbiology of Pfizer Consumer Healthcare, and R&D of Johnson & Johnson. He has received numerous awards, is senior associate editor for the Journal of Oral Implantology, an ITI Fellow, and Academic Associate Fellow of American Academy of Implant Dentistry.

Course Description

The presentation will focus on clinical details that may lead to the success or failure of tooth extraction, grafting, positioning the implant, and restoring the implant. In 2025, what do we know that may interfere with the outcomes? The role of extraction details compared to implant placement, placing the implant in the ridge, and designing the emergence profile will be discussed. All little details drive the results.

Learning Objectives

At the end of this course, participants will be able to:

- Assess the criteria for extraction and then operate accordingly
- Identify risk factors for bone health
- Evaluate proper grafting techniques and make material choice suggestions
- Understand surgical implant placement: Where to place the implant based on gingival phenotype and position in the arch
- Design an appropriate emergence profile to prevent gingival pressure
- Recognize dedicated recall protocols
