Biography

Dr. Carlo Ercoli is a tenured professor of Prosthodontics, Periodontics, and Implant Surgery and chairman of the Prosthodontic Department at the University of Rochester, Eastman Institute for Oral Health, where he also serves as the director for the Center of Excellence for Digital Dentistry and associate director for Strategy and Innovations. He graduated from the Enrico Berlinguer Dental Technology Institute in Rome in 1987 and obtained his DDS from the University of Siena, Italy in 1993. He specialized in Prosthodontics in 1996 at the Eastman Dental Center in Rochester, New York and completed a specialty training in Orofacial Pain and Temporomandibular Joint Disorders in 1997. In 2012, he achieved specialty certification in Periodontology. In 2019, he obtained his MBA from the Simon Business School of the University of Rochester.

Dr. Ercoli is a past president of the American Prosthodontic Society, vice-president of the Academy of Prosthodontics, vice-president of the American Academy of Fixed Prosthodontics, honorary member of the Italian Academy of Prosthodontics, founding member of the Italian Society of Prosthodontics and Oral Rehabilitation Education, and research director of the American College of Prosthodontists, board member of the American College of Prosthodontists Education Foundation, and director of the American Board of Prosthodontics. Dr. Ercoli is a diplomate of the American Boards of Prosthodontics and Periodontology, an ITI fellow and chair of the USA ITI East Region, in addition to serving as a member of the World Workshop on the Classification of Periodontal and Peri-implant Diseases and Conditions. He is the 2026 Scientific Program Chair of the Greater New York Academy of Prosthodontics. He holds memberships in the American College of Prosthodontists, American Academy of Periodontology, American Dental Education Association, Academy of Osseointegration, American Academy of Fixed Prosthodontics, Greater New York Academy of Prosthodontics, and American Prosthodontic Society. He lectures nationally and internationally on dental implantology.

Course Description

Anterior esthetic cases are the ultimate areas where biology meets technology. It is in this anatomical and functional area that most processes of health and disease are actually initiated, maintained or compromised with short- and long-term effect on the prognosis of the dental implant and its surrounding hard and soft tissues. It is in this area where implant and prosthetic restoration design, biomaterials, technology, and hard and soft phenotype interact and become relevant for long-term biomimetic behavior of our restorations. This presentation will review how technology, biomaterial, prosthodontic restoration design and esthetics interact with peri-implant tissues and how to efficiently and judiciously apply these concepts from single implants to full-arch prostheses. The relevance of prosthetic design, soft and hard tissue grafting and the interaction between biomaterials and prosthetic workflows will be highlighted and assessed within a framework of efficient, evidence-based care delivery.

Learning Objectives

- Understand how digital workflows can enhance the diagnosis, planning and execution of simple and complex implant cases.
- Learn about the interactions between prosthetic emergence profile and soft tissues esthetics.
- Assess case complexity and inform treatment decision in the best interest of the patient.
